CURRENT COGGINS MUST ACCOMPANY ENTRY (uploaded) TO BE COMPLETE (within 12 months) Add a \$35 late fee if your entry is received after the closing date (May 15).

**Grounds Fee:** \$20 fee for all horses not stabled.

**Stabling:** Limited on grounds - \$120 (new stabling). No bedding provided. Please send in a separate \$30 clean stall deposit check payable to Revel Run 555 S. Dancer Rd. Chelsea MI 48118; check will be torn up if the stall is stripped after use. Please put rider and horse name on check. If to be stabled in a group, all riders must use same group name when requesting stalls together.

**Parking:** ALL TRAILER PARKING IS AT 555 S. Dancer Road. \*\*\*Please drive slow on dirt roads coming to Revel Run\*\*\*
