Rules for Participating in Blue Horse Entries Virtual Events

General:

- All shows should be considered schooling shows and are unaffiliated with any organization or group unless otherwise noted.
- All judge decisions are final.
- Blue Horse Entries reserves the right to refuse any entry at any time. Policies, procedures, and prices are subject to change without notice.
- Riders/Owners/Exhibitors/Handlers/Respective Persons must follow the rules of their state/provincial, territorial or country's governing body.
- Classes can only be entered one time per horse/rider combination.

Riders and Horses:

- All equipment must comply with USEF/USEA/USDF/WDAA guidelines.
- Helmets and proper footwear MUST BE WORN AT ALL TIMES.
- ALL riders in ARE REQUIRED to wear a ASTM (American Society for Testing Materials) or BSI approved helmet, with safety harness correctly fastened.
- Show attire is not required; however, correct schooling attire appropriate for your discipline is expected.

Arena Requirements:

- Your dressage arena does not need to be formal or fancy in order to participate in a Blue Horse Virtual Event. Feel free to mark the perimeter with poles on the ground, ropes, etc. Letters can be marked on cones, drawn on paper and taped to buckets, or other objects, as long as they are clearly visible in the video.
- The videographer should stand at C. Zooming in is allowed but not required. Horse and rider must remain fully in the video frame for the entirety of the video.
- At the start of your video please announce or display a written version of the following information: Your name, your horse's name, and the test you are riding.

Videos:

- Videos must be filmed in horizontal/landscape orientation.
- Videos must be unedited and continuous with original audio. Editing and/or stopping the video is not allowed. Only one clip may be submitted per test.
- Original audio must be included, audible, and unedited. Coaching, earbuds, and music are not permitted. Calling of dressage tests, as consistent with USDF/ USEF/ USEA/ WDAA rules, is permitted.
- The same video cannot be submitted more than once. Videos from other events, competitions, or clinics both in person and virtual are not permitted.
- Dimensions for small dressage arenas should be 20X40 meters (or approximately 66 feet x 132 feet). Dimensions for standard or long dressage arenas should be 20X60 meters (or approximately 66 feet x 197 feet).
- If a video does not meet the requirements, it will not be scored and there will be NO REFUND. Please ensure videos meet all requirements before submitting.
- All payments MUST be received before videos may be submitted. Failure to submit a completed entry with payment will result in any related videos being rejected.

- If videos are not submitted by the close date, NO REFUNDS will be given.

Refunds:

Blue Horse Entries does not offer any refunds after an entry has been submitted unless Blue Horse Entries cancels the event in its entirety.

Refunds are not given for participants who fail to submit videos within the submission window (between the Open Date and the Close Date), nor for participants who fail to meet the rules for video submission and participation. Participants are encouraged to submit videos as early as possible during the submission window; the Blue Horse Entries team will work to, but cannot guarantee, review each video as it is submitted to ensure compliance with requirements and may contact participants with the opportunity to resubmit if requirements are not initially met. Any resubmissions must happen within the submission window before the Close Date.

In the event of a cancelled virtual competition, participants who have submitted and paid for entries will be given the option of receiving a refund or a credit to a future Blue Horse Entries virtual event. Credits are only applicable for other Blue Horse Entries virtual events, and are not applicable for in-person events or events organized by other users of the Blue Horse Entries platform.

In the event of a horse or rider injury that prevents the participants from recording and submitting their video(s), participants may contact Blue Horse Entries at contactus@bluehorseentries.com prior to the closing date of the event to receive a credit for a future Blue Horse Entries virtual event. Credits are only applicable for other Blue Horse Entries virtual events, and are not applicable for in person events or events organized by other users of the Blue Horse Entries platform.

Release & Waiver of Liability, Assumption of Risk, and Indemnification Agreement:

PLEASE READ CAREFULLY BEFORE SUBMITTING AN ENTRY.

By submitting an entry through Blue Horse Entries, you are entering into a legally binding Release of Liability with Blue Horse Entries LLC ("BHE") and its affiliates, subsidiaries, owners, employees, judges, volunteers, contractors, and agents (the "Released Parties").

1. Assumption of Risk - Equine Activities

I understand that equestrian activities are inherently dangerous and involve serious risks, including injury, permanent disability, or death. Risks include but are not limited to unpredictable horse behavior, equipment failure, rider error, and hazards of the environment. I voluntarily assume these risks.

2. Waiver and Release of Liability

To the fullest extent permitted by law, I waive, release, and discharge the Released Parties from all liability, including claims based on ordinary negligence, arising from my participation in any activities, events, or services provided by BHE, whether virtual or in-person. This does not waive claims of gross negligence, willful misconduct, or intentional acts where such waiver is prohibited by law.

3. Equine Activity Liability Acts (EALAs)

I understand that certain states have Equine Activity Liability Acts which limit liability for equine professionals. This release is intended to be interpreted as broadly as permitted by those laws. NOTICE TO PARTICIPANTS: Under state law, an equine professional is not liable for injury or death resulting from the inherent risks of equine activities.

4. Indemnification

I agree to defend and hold harmless the Released Parties from any claims, damages, or expenses (including attorneys' fees) arising from my participation or from claims brought by third parties related to my actions.

5. Minors

If I am registering a participant under 18, I represent that I am the parent or legal guardian and consent to this Release on their behalf. I further agree to indemnify the Released Parties against claims brought by or on behalf of the minor, to the extent permitted by law.

6. Governing Law & Dispute Resolution

This Agreement is governed by the laws of [State where BHE is based]. Any dispute shall be resolved by binding arbitration before the American Arbitration Association, and I waive any right to a jury trial.
